**Subject:- Integrated Cement manufacturing unit of M/s Bhavya Cements Ltd. at Thangeda Village, Dachepally Mandal, Guntur Dist, Andhra Pradesh- Extension of validity of Environmental Clearance regarding.**

Sir,

This has reference to your letter No. BCL/EC/C/1 dated 12<sup>th</sup> December, 2014 and subsequent letter No. BCL/EC/r/2 dated 15<sup>th</sup> September, 2015 for Extension of validity of the Environmental Clearance.

2.0 The integrated Cement Plant project of M/s Bhavya Cements Ltd. for 4 Million TPA (8500 TPD) Capacity, 15 MW captive power plant and Captive mining located at Thangeda Village, Dachepally Mandal, Guntur District, Andhra Pradesh was accorded Environmental Clearance by the Ministry vide letter No. F. No. J-11011/1186/2007-IA II (I) dated 22.09.2008.

3.0 Earlier, the proposal was considered during the 31<sup>st</sup> meeting of the Expert Appraisal Committee held on 8<sup>th</sup> - 9<sup>th</sup> January, 2015. The Committee noted that the Environmental Clearance has been expired on 21.09.2013 and the project proponent had applied for seeking extension on 12.12.2014, i.e. after the expiry of Environmental Clearance. The Committee after deliberations decided that the matter may be referred to the Ministry for a decision.

4.0 The matter was examined in the Ministry. Meanwhile vide amendment Notification dated 29<sup>th</sup> April, 2015, the Ministry had extended the period of validity of Environmental Clearance from 5 years to 7 years. Therefore, the Environmental Clearance accorded vide letter dated 22.09.2008, holds valid upto 21.09.2015. The project proponent was accordingly informed vide letter dated 11<sup>th</sup> September, 2015.

5.0 The project proponent has therefore, vide letter No. BCL/EC/C/r/2 dated 15<sup>th</sup> September, 2015 submitted an application to Ministry for seeking extension of validity of Environmental clearance for further period of 3 years, as per amendment Notification dated 29.4.2015.


6.0 The above proposal was again considered by the Expert Appraisal Committee (Industry-I) in its 1<sup>st</sup> meeting held during 18<sup>th</sup> -20<sup>th</sup> November, 2015. The committee after detailed deliberation recommended the proposal of extension of validity of Environmental Clearance dated 22<sup>nd</sup> September 2008 for further period of 3 years i.e. up to 21<sup>st</sup> September, 2018.

7.0 The Ministry accepts the recommendation of the EAC (Industry) and hereby extend the validity of the Environmental Clearance J-11011/1186/2007-IA.II(I) dated 22.09.2008 for further period of 3 years i.e. upto 21.09.2018 under the provisions of EIA Notification, 2006, as amended.

8.0 All the conditions stipulated in the environmental clearance letter No. J-11011/1186/2007-IA.II(I) dated 22.09.2008 shall remain the same.


9.0 The company shall obtain fresh environmental clearance in case of any change in the scope of the project.
